**2023-2024 New Student Application Fee (non-refundable)** - Application fee is due for new students to be considered for admission to the school. This is the first step in the application process. Please refer to [Apply to FCS](#) for additional instructions.

\* Fixed Fees and first month tuition are non-refundable and are due in full regardless of enrollment date, financial assistance, or scholarships received, or withdrawal date, if applicable.

## **Payment Plans**

Every family is required to select a tuition payment plan at the time of enrollment/ re-enrollment. There are 3 payment plan options. The payment plan includes Tuition, Campus Improvement and Security Fee in equal installments consistent with the payment plan selected. All payment plans include the **non-refundable tuition installment**.

Beginning on June 1 <sup>st</sup> , 12 monthly installments based on the Total Annual Cost will be due which include Annual Tuition and Fixed fees.	One full payment is due on June 1 <sup>st</sup> . A 5% discount on tuition will be applied for payments made by the due date via ACH or check. Discount is not applicable if paid by credit card.	Two total payments due at 50% of total per semester. Fall semester due June 1 <sup>st</sup> . Spring Semester is due December 1 <sup>st</sup> . A 2.5% discount on tuition will be applied per semester for payments made by the due dates via ACH or check. Discount is not applicable if paid by credit card.

## **Multiple Child Discount**

Tuition is assessed at the full rate for the oldest student attending Florida Christian School from the same family (household). A multiple child discount is granted to offset tuition for each additional sibling enrolled living in the same household at the following rates:

10% discount – 2nd student

20% discount – 3rd student

30% discount – 4th student

**Regardless of the payment plan selected, non-refundable fees are as follows:**

### **Campus Improvement and Security Fee \$750 (non-refundable)**

The Campus Improvement and Security Fee of \$750 will be billed to each family (household) following enrollment. The Campus Improvement and Security Fee may be paid over installments consistent with the payment plan selected. Regardless of payment plan selected, the non-refundable Campus Improvement and Security Fee is due in full to FCS.

### **Book / Class Fee**

The cost for textbooks and workbooks for all students is now included in the monthly tuition payments. Textbooks will be purchased by the school and provided to students at the beginning of the school year. Additionally, Classroom Celebration fees have also been included in Elementary and Preschool tuition to cover your student for all class parties during the school year.

## **Withdrawal – Dismissal**

When seeking a withdrawal from school, please contact the Admissions department.

A [Withdrawal Form](#) must be signed by the financially responsible parent or legal guardian.

After careful consideration, a student may be dismissed when he or she is found out of harmony with the [regulations and policies](#) of the school.

If dismissed or withdrawn, students must turn in all school issued equipment, team uniforms, library books, etc., on his/her last day of attending school. All accounts must be cleared (no past-due balance) for records to be released.

Following a student's withdrawal or dismissal, school records and report cards will not be given to families whose financial account is past due. Students who attend a portion of a month will be liable for the entire month of tuition. [Application Fees](#), [Enrollment Fees](#), and [Campus Improvement and Security Fee](#) are due in full, regardless of the payment plan selected or withdrawal date. Additionally, the withdrawing student will be charged a \$250 book fee for the textbooks purchased for them by the school. Families who withdraw their student or who are dismissed will not receive a refund. Refunds permitted will be for those families who have paid in advance more than one month of tuition for periods after the withdrawal/dismissal date.

## **After School Care**

After School Care costs for the 2023-2024 school year:

- DAILY = \$20.00 / DAY
- WEEKLY = \$60.00 / WEEK
- SURCHARGE = \$15.00 / 1ST 10 minutes, or any part thereof, and \$1.00 / MINUTE for each additional minute thereafter, will be charged to any student that is picked up after 6:00 PM.

## **Other Fees and Services**

Student support services such as Educational Therapy, Academic Enhancement, Search & Teach, Intensive Reading, and Intensive Math have separate rates as to what is mentioned above. Prices can range from \$2,600 to \$8,000.
